Requirements:

- If a child is under the age of 18, he/she must be chaperoned at all times.
- Horses and other animals must be kept under control at all times and an adult must accompany the rider/entrant.
- Entrants can be removed by any parade official, fire department representative or law enforcement officer.
- No guns or projectile weapons of any type, at the request of the Molalla Police Department.
- Motorized vehicles requiring Oregon licensing and registration must have a licensed driver.
- Children operating off-road vehicles (i.e. ATV) must be accompanied by a licensed driver and wear a helmet.
- Animals, excluding horses, must be caged or leashed.
- Clean up after yourself and your animals.
- **Please have a liability release statement signed by the parent/guardian of each child.**

Ribbons: First, Second and Third place will be awarded in each category. Grand champion will be awarded to the overall winning entrant.

Route: Assemble at Bohlander Field for registration and judging. Please enter through the Heintz Street entrance. Registration and Sign-In will begin at 3:45 P.M. and close at 5:00 P.M. Judging will begin at 5:15 P.M. Parade begins at 6:00 P.M.

Start at Bohlander Field - West on Heintz Street to Grange Avenue - South on Grange Avenue to Main Street - West on Main Street to Molalla Avenue - North on Molalla Avenue to Heintz - Disband on Heintz Street behind Cutter's Hi-School Pharmacy

Release of Liability

My child, entry group, and/or I desire to voluntarily participate in the Molalla Kiddie Parade upon my own initiative, risk, and responsibility. In consideration for permitting me to participate in this parade, I hereby release and forever discharge the Sponsors of the Molalla Kiddie Parade, Country Christian Outreach Program, Country Christian Schools, Molalla Fire District #73, the Molalla Area Chamber of Commerce, the Molalla Buckeroo Association, the City of Molalla, and the Oregon Department of Transportation, their officers and agents, their individual and business members, their successors and assigns (collectively the "Released Parties:), acting officially and otherwise, from any and all claims, demands, actions or causes of action (a "Claim"), on account of the death, injury, or illness to any family member or of any animal owned by me which may occur as a result of or arise from, my participation in or preparation for the parade, regardless of how arising, including any such Claim resulting from the negligence of a Released Party.

This release also includes any Claim for damage or loss of any vehicle, trailer, horse, animal, or float owned, managed, or operated by me and includes any preparation for the Kiddie Parade, any movement to, from, or during the parade.

I further represent that any vehicle, trailer, or float that I enter and/or operate in the Kiddie Parade is safe with no known mechanical or safety defects, which I will inspect for. I will not operate nor will I allow the operation of any vehicle, trailer, or float owned or operated by me in an unsafe or reckless manner.

If my entry includes an animal or animals, I agree that the animal(s) will be kept under control at all times before, during, and after the Kiddie Parade. I am aware that any animal(s) can be removed from the parade by any Fire Department Representative, Parade Official, or Public Safety Officer for any reason, including if the animal is deemed to be out of control or of danger to any other participant and/or spectator.

I further represent that I will defend, indemnify, and hold harmless the Released Parties, acting officially or otherwise, from any and all Claims, demands, actions or causes of action which may arise or result from or out of my participation in or preparation for Kiddie Parade activities, including but not limited to, Claims from any person who rides in or on or be around my vehicle, trailer, animal, horse and/or float. This release is binding on my heirs, successors, assigns, executors, administrators and personal representatives.

I have read and understand the above agreement and agree to abide by the terms set forth.
