Dear Mr. Garrett,

Please accept this joint letter from the City of Molalla City Council and the Molalla River School District Board of Directors as a unified request for the Oregon Department of Transportation to move forward on important safety issues in our community.

First, there is a potentially grave issue for children along Highway 211 (Main Street) near the intersection of Hezzie Lane with regard to pedestrian safety. With 300 Apartment units and additional development pending we fear that children walking to and from the schools only one block away will be in danger of crossing a highway unprotected. This is our formal request of you to take action to assure children and families' safety.

Secondly, the City has recently asked for no parking signs in front of Stone Place Apartments to improve sight distance and have received no response. Site distance and safety for pedestrians and bicyclists will improve with these formal parking restrictions.

Finally, we believe that the traffic speed in this area should be lowered. The City's Public Works Director will be submitting a request to the State Traffic Engineer.

These issues regarding pedestrian and bicycle safety are of high importance to this community, especially when it involves the safety of children. If you have questions or need clarification please contact Molalla City Manager, Dan Huff or Molalla River School District Superintendant, Tony Mann.

Chapter 12.12 PUBLIC WORKS STANDARDS

12.12.010 Adoption of specifications. - Existing

The City of Molalla adopts Standard Specifications and Drawings for Public Works Construction, published by the Oregon Chapter, American Public Works Association, 1972. (Ord. 1975-6 §1)

Title 12 STREETS, SIDEWALKS AND PUBLIC PLACES Chapter 12.12 PUBLIC WORKS STANDARDS

12.12.010 Adoption of design and construction specifications. - Proposed

The City of Molalla adopts current version Molalla Public Works Standards and City standard detail drawings for design and construction standards or as determined by the Public Works Director.

12.12.020 Updates to the Public Works Standards. - Proposed

The Molalla Public Works Standard may be updated administratively by the Public Works Director to address changes in departmental operation and maintenance needs, technology, material standards, agency permitting requirements, and state or federal rules and regulations. Revisions shall be posted electronically to the City's website.

12.12.030 Notification List for Updates. - Proposed

Interested parties may request to be placed on a notification list for updates to the Public Works Standards. The list will be maintained at the office of the Public Works Director and interested parties must submit their requests in writing on a form provided by the Public Works Department.
