RESOLUTION 2014-11 CITY OF MOLALLA

A RESOLUTION AMENDING RESOLUTION 2014-06, MAKING APPROPRIATIONS FOR THE FISCAL YEAR 2014/2015.

The City Council of the City of Molalla, Oregon, on the 22nd day of October, 2014 during regular session for the transaction of City business.

WHEREAS: On June 11, 2014, the Molalla City Council passed Resolution 2014-06, adopting a budget, making appropriations, imposing and categorizing taxes for fiscal year 2014/2015; and

WHEREAS: Appropriations can be transferred within a fund from an existing appropriation category to another existing appropriation category by resolution or ordinance as long as the net change in the fund's total appropriations is zero; and

WHEREAS: Operating contingencies were created in funds and can be used as long as the contingency appropriation is reduced and the receiving appropriation category is increased by the same amount so the fund remains in balance; and the amount which may be transferred from contingency by resolution is limited to 15 percent of the total appropriations in the fund.

WHEREAS: Municipal governments receive revenues that need to be recognized and appropriated for use.

NOW, THEREFORE, THE CITY OF MOLALLA RESOLVES: as follows:

- 1. Authorizes the appropriation changes as outlined in exhibit A;
- 2. Authorizes the Finance Director to amend the FY 2014/2015 budget to reflect the changes in Exhibit A.

EXHIBIT A

The following is taken from the Oregon Department of Revenue, Local Budgeting Manual, Property Tax Division:

Resolution transfers

The adopted budget may include budgeted transfers of resources between funds. In addition, it often becomes necessary after the budget is adopted to transfer appropriation authority (and in some cases, resources) from one fund to another or between appropriation categories within the same fund. The governing body may authorize some transfers of appropriation authority by passing a resolution or ordinance. A transfer of appropriation authority is a decrease of one existing appropriation and a corresponding increase of another existing appropriation, with no net change in the total amount of all appropriations [OAR 150-294.450(3)(1)]. In general, a resolution may not be used to authorize the creation of a new appropriation category that does not already exist.

Contingency transfers

A common situation in which appropriations are transferred from one category to another within a fund is when a specific need is identified for money that was budgeted and appropriated as operating contingency. To make the expenditure, the appropriation authority must be transferred from the contingency category to the appropriation category from which it will be expended. The contingency appropriation is reduced and the receiving appropriation category is increased by the same amount so the fund remains in balance. 150-504-420 (Rev. 05-12) 68

The amount which may be transferred from contingency by resolution is limited to 15 percent of the total appropriations in the fund [ORS 294.463(2), renumbered from 294.450(2)]. Transfers of contingency which in total exceed 15 percent in a year may be made only after adopting a supplemental budget for that purpose. If there is no existing appropriation in the category in which the desired expenditure falls, a supplemental budget is required to create the new appropriation.

Example of the 15 percent calculation: If the appropriations in a fund total \$100,000, including \$20,000 for general operating contingency, only 15 percent, or \$15,000, of the appropriations, may be transferred from the contingency appropriation by resolution or ordinance. The remaining \$5,000 of contingency can be transferred only through a supplemental budget.

Therefore, using the previously stated guidelines as a foundation, the finance department recommends a resolution adjustment to the FY 2014/2015 budget as follows:

Ordinance 2014-31

AN ORDINANCE AMENDING CHAPTER 12.28 OF THE MOLALLA MUNICIPAL CODE BY ADDING SECTION 12.28.050 REGARDING NAMEING AND RENAMING OF STREETS.

WHEREAS, The Molalla City Council finds that there are situations and purposes to changing existing street names throughout the City of Molalla; and

WHEREAS, language within the current Municipal Code does not provide process or procedure to accomplish that goal; and

WHEREAS, adopting process and procedure for street naming and renaming is in the best interest of the City of Molalla.

NOW, THEREFORE, THE CITY OF MOLALLA ORDAINS AS FOLLOWS:

Section 1. The Molalla Municipal Code Chapter 12.28 is hereby amended to include the following language:

Street names shall be approved by the City.

In the course of development by public and private parties, there shall be new streets established. When development is proposed by the City, the council shall establish the names of public streets. In the course of other development such as subdivisions or planned developments, the officials designated to make final decisions on such development (typically the planning commission or City manager designee) shall establish names for any public and private streets as part of that decision.

Street names shall not be confusing.

Developers may propose names for streets as part of their application for development or improvement (such as an unnamed alley). Proposed names shall be reviewed by the city, the fire district, and 911 district to avoid conflicts with similarly sounding names. Except for extensions of existing streets, no street names shall be used that will duplicate or be confused with names of existing streets. Street names and numbers shall conform to the established pattern in the surrounding area and be subject to approval of the city.

Street name changes.

- A. An action to rename a street in the city may be initiated by the council:
 - 1. On its own action; or
 - 2. If a person files a petition as described in this section accompanied by a fee reasonably related to the costs of the process.
- B. A Petition for naming or renaming a street shall include the following:
 - 1. A statement of the reasons for the proposed name change.

- 2. The name and address of all persons owning real property abutting the street proposed to be renamed and existing addresses abutting the street proposed to be renamed. For the purposes of this section, "owner" means the record holder of legal title to land, except that if there is a purchaser of the land according to a recorded land sales contract, the purchaser is the owner.
- 3. Signatures of 60 percent of all owners of the land abutting the street proposed to be renamed.

C. Notice and Hearing

- 1. The processing procedure for a street name change shall occur in conformance with a Type IV Procedure.
- 2. Upon adoption of an ordinance approving the street name change by the city council, notice shall be sent to the Clackamas County Surveyor and Clackamas County Assessor, all departments within the City, Fire District, School District, All property owners affected by the street name change and the Post Office.

D. Criteria for Approval

The planning commission and city council shall determine whether the name change is in the public interest and is necessary due to confusion as a result of similarity in sound or spelling such as Meadowlawn and Meadowlark, complexity of pronunciation or spelling, or the result of the need for continuation of a street name where confusion may be created as a result of two different street names on a through street. No Street shall be given a name that is the same as, similar to, or pronounced the same as any other street in the city unless that street is an extension of an already existing street. Whenever practical, historical names, names of Native American tribes of Clackamas County, heirs of original settlers or long-time residents of Molalla or names relating to Molalla's natural environment will be considered in the renaming of public streets.
