# A. Resolution 2014-03: A Resolution Authorizing Indebtedness for Capital Projects Described in the Molalla Urban Renewal Plan

FD Penni explained that the only changes are the Resolution has the contract in the back marked "Draft". There are lines that need to be filled in however they won't be filled in until the City is going through the financing process.

Laura Ferris, 300 Stowers. Ms Ferris asked if the tax increment revenues were based on actuals or estimates. FD Penni advised that it is based on actuals based on half the growth that the county is projecting.

Ms. Ferris stated that the amount of 26 million is different than what is in the City's adopted budget. FD Penni explained that 26 million is what was accepted in the actual plan.

Ms. Ferris asked if this will affect taxpayers. FD Penni advised that this will not affect taxpayers, she explained that this is a tax increment financing from the Urban Renewal District, a 14 year bond.

Member Clark asked what happens if the market falls and the City doesn't have the revenue to pay the loan. FD Penni stated that the City will have the revenue because it is at the base that it is right now and the City is receiving an average \$310,000 per year.

Member Griswold asked how outstanding liens affect the bonding for the URA. He was advised that there would be no impact.

Member Boreth asked if the properties in the URA are typical of residential where taxes increase 3% per year. FD Penni advised that there is a variety of different types of properties.

Member Clark stated that he is in favor or loans vs. grants. CM Huff stated that a revolving loan is preferred.

Member Boreth made a motion to adopt Resolution 2014-03. Member Cook seconded. Motion approved (6-1) Member Rogge, Aye; Member Pottle, Aye; Member Clark, Aye; Member Thompson, Aye; Member Griswold, Nay; Member Boreth, Aye; Member Cook, Aye.
