A. Minutes January 14, 2015

NEW BUSINESS

A. Intent to Award Molalla URP – W. Heintz Street

The City had chosen to allocate Urban Renewal funds to construct roadway improvements on W. Heintz Street. The design portion of the project was completed last month and placed on advertisement in May with Bid Opening on Tuesday, June 9th. The included document lists three received bids with the apparent Low Bid of \$1,340,663.00 submitted by Westech Construction. The bids were verified and the "Notice of Intent To Award" was published on June 9, 2015 noted as Exhibit A and can be found with the agenda at City Hall and posted to the website. The City recommends an Intent to Award the contract to Westech Construction for the bid amount of **\$1.340,663.00 on Wednesday, June 17th, 2015**.

The agency questioned the amount listed on the agenda cover sheet and the notice of intent to award because they were different. The notice states \$1,305,577.75. Penni stated that the

engineers came up with a higher number and would recommend that the agency approve the \$1,340,663.00 with any amounts exceeding the low bid of \$1,305,577.75 to come back to the agency for approval. Member Pottle motioned to accept the intent to award with Penni's recommendations. Thompson seconded. Motion approved (6-0)
