## **Other Information\***

**Molalla Municipal Code 13.04.070 requires a written application for water service.** All applications shall include signature of person/persons responsible for the bill at the requested address, a current address where all bills shall be sent, and additional data to secure any accrued water/sewer debts.

**Molalla Municipal Codes 13.04.200 and 13.08.360 require a deposit and establishment of credit.** This deposit shall not be applied to water/sewer bills as payment. The deposit is refundable upon termination of service and can be applied at that time or after 1 year of current monthly payments.

**Tampering/Obstruction of Meter:** Any tampering of or unauthorized access to the water meter is subject to additional fees and fines. As water meters are property of the City, City personnel must have access to meters at all times. Please contact the City should you need the water turned on or shut off at the main meter. Customers are NOT to turn on or off the water meter at any time. Often times there is a customer shut off valve on the property. The City does not know where the customer valve is located.

**Payment options:** The City accepts cash, check, money order & debit/credit cards. Payments can be made online by card or e-check at [www.xpressbillpay.com](http://www.xpressbillpay.com), by phone at 1-866-399-8703, in person during business hours, by mail, or by depositing a check or money order in the drop box outside City Hall.

***All charges for water and sewer service will be due and payable monthly on the date of mailing, and become delinquent on the sixteenth (16th) day thereafter.***

## **Basic Current Rates\***

- Sewer base: \$55.94 per EDU (Equivalent Dwelling Unit) per month.
- Sewer usage: Fixed fee shall be based on a rate per equivalent dwelling unit (EDU) of \$5.95 per month. The variable fee shall be based on the per hundred cubic feet (CF) of winter average water consumption which comes out to \$5.95.
- Water meter: \$15.54 for 3/4" line per month (see fee schedule for other meter sizes).
- Water usage: Billed on consumption at \$3.57 per 100 cubic feet (0 - 500 cubic feet), \$3.93 per 100 cubic feet (501 - 1000 cubic feet), \$4.46 per 100 cubic feet (over 1000 cubic feet) billed every month.
- Outside the City limits shall be 150% of the rates.
- These rates are adjusted annually on July 1, based on the published values by the Bureau of Labor Statistics Portland-Salem for all Urban Consumers (CPI-U) as per Molalla Municipal Code 13.04.
- See fee schedule for other rates.

## **Basic Fees/Deposits\***

- Sewer deposit \$50.00 (Residential & Commercial) *refundable*.
- Water deposit \$50.00 (Residential & Commercial) *refundable*.
- Shut Off/Reconnect Fee \$50.00 (fee for water service that has been terminated for failure to respond to the termination notice and then restored after payment).
- Late Fee \$15.00 (defined as all accounts with a balance of greater than \$5.00 as of 12:00 am Pacific Time on the first business day after the 15<sup>th</sup> of the month).
- Storm Drain Fee \$4.78 per month per EDU of impervious surface.
